



**RESOLUTION NO. 1528**

**DESIGNATING SAN JOSE, OCCIDENTAL MINDORO  
AS AN ADDITIONAL TESTING CENTER FOR THE DECEMBER 2022  
LICENSURE EXAMINATION FOR CRIMINOLOGISTS**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations;**

**WHEREAS**, pursuant to Resolution No. 1439 (s. 2021), the scheduled Licensure Examination for Criminologists (LEC) will be on December 4, 5 & 6, 2022 to be held in the National Capital Region, Baguio, Butuan, Cagayan de Oro, Cebu, Davao, Iloilo, Koronadal, Legazpi, Lucena, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, Zamboanga, and Cauayan;

**WHEREAS**, the Office of the Mayor of San Jose, Occidental Mindoro requested the Professional Regulatory Board for Criminologists (Board) and the Commission to consider San Jose, Occidental Mindoro as one of the testing centers for the December 2022 LEC;

**WHEREAS**, the Commission issued Resolution No. 1493 (s. 2022), otherwise known as the “Revised Guidelines and Procedures on the Designation of Additional Testing Centers for The Conduct of Local Licensure Examinations”, which provides that additional testing centers for large-scale examination outside the city or province where the PRC Regional Office is located must have at least 300 prospective examinees;

**WHEREAS**, LEC is a large-scale licensure examination and there are more or less three hundred (300) prospective examinees for the December 2022 LEC in San Jose, Occidental Mindoro;

**WHEREAS**, PRC MIMAROPA Regional Office, in its June 23, 2022 Memorandum, endorsed the request to the Professional Regulatory Board of Criminology (Board) and the Commission for consideration;

**WHEREAS**, the Local Government Unit of San Jose, Occidental Mindoro committed to shoulder the expenses for rental, transportation, food, and accommodation of the delegation team;

**WHEREAS**, the Board and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the December 2022 LEC without unnecessary distant travel and additional expenses;

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **SAN JOSE, OCCIDENTAL MINDORO** as an additional testing center for the **December 2022 Licensure Examination for Criminologists**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
