**DESIGNATION OF ADDITIONAL TESTING CENTERS AND SCHEDULE
FOR THE 2022 REAL ESTATE CONSULTANTS LICENSURE EXAMINATION –
REVALIDA**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) scheduling the licensure examinations for calendar year 2022 wherein the Real Estate Consultants Licensure Examination (RECLE) – Revalida is scheduled on January 3-7, 10-14, 17-21, 2022 and February 7-11, 14-18 & 21-25, 2022 to be held in the National Capital Region;

WHEREAS, the Professional Regulatory Board of Real Estate Service (Board) issued Resolution No. 149 (s. 2021) authorizing the conduct of online Revalida for Real Estate Consultant examinees and providing interim guidelines thereto;

WHEREAS, the Board, in its letter dated 12 January 2022, proposed to designate additional testing centers in the regions due to the rising cases of COVID-19 infection in Manila and the imposed travel restrictions;

WHEREAS, while cases of COVID-19 infections continue to go down and travel restrictions are being relaxed from the time the Board sent its request, the risks posed by the pandemic still persists;

WHEREAS, the Board and the Licensure Office have agreed to recommend the designation of additional testing centers with their corresponding schedules for the 2022 RECLE – Revalida, taking into account the health and safety of all concerned;

WHEREFORE, upon motion duly made, the Commission **RESOLVES** to designate the PRC Regional Offices of Cagayan De Oro, Cebu, Iloilo, Baguio, Legazpi and Davao as testing centers for the Real Estate Consultants Licensure Examination – Revalida on the dates specified below:
