**RESOLUTION NO. 1650**

**DESIGNATING STA. CRUZ, LAGUNA AS AN ADDITIONAL TESTING CENTER FOR THE SEPTEMBER 2023 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

**WHEREAS**, pursuant to Resolution No. 1589 (s. 2022), the Licensure Examination for Professional Teachers (LEPT) is scheduled on September 24, 2023 in various testing centers nationwide;

**WHEREAS**, the Commission issued Resolution No. 1493 (s. 2022), otherwise known as the “Revised Guidelines and Procedures on the Designation of Additional Testing Centers for the Conduct of Local Licensure Examinations,” which provides that additional testing centers for large-scale examination outside the city or province where the PRC Regional Office is located must have at least three hundred (300) prospective examinees;

**WHEREAS**, in view of the success of the recently conducted March 2023 LEPT in Sta. Cruz, Laguna, the Office of the Vice Governor (LGU) signifies its intent to host the September 2023 LEPT, for the second time;

**WHEREAS**, the LGU of Sta. Cruz, Laguna expressed its commitment to shoulder the expenses for transportation, accommodation and meals of the PRC delegates;

**WHEREAS**, the LEPT is considered a large-scale licensure examination and there are more or less two thousand five hundred (2,500) prospective examinees for the September 2023 LEPT in Sta. Cruz, Laguna;

**WHEREAS**, in its letter dated 03 May 2023, the PRC Regional Office IV-A (Lucena) expressed its willingness to conduct the September 2023 LEPT in Sta. Cruz, Laguna, and recommended the approval of the said request;

**WHEREAS**, the Professional Regulatory Board for Professional Teachers and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the September 2023 LEPT without unnecessary distant travel and additional expenses;

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **STA. CRUZ, LAGUNA** as an additional testing center for the **SEPTEMBER 2023 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
