

3. ALL EXAMINEES ARE REQUIRED TO WEAR THEIR RESPECTIVE COLLEGE UNIFORM per Resolution No. 311 dated May 18, 1994.
4. Bring the following on examination day:
  - a. Notice of Admission
  - b. Official Receipt
  - c. One (1) piece metered-stamped window mailing envelope
  - d. Two (2) or more pencils (No. 2)
  - e. Ball pens with **BLACK ink only**
